



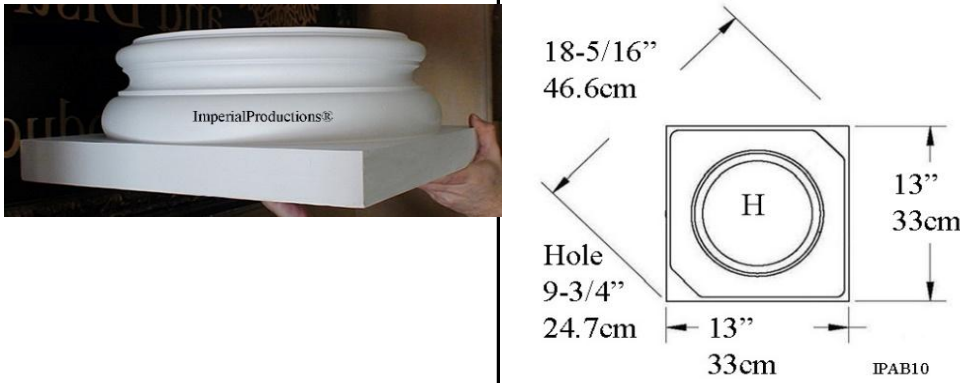

Imperial sells unfinished architectural components, specialty finished components, and does not install goods. Imperial is a vital part of the manufacturing process which includes product design, drawings, modifications, and co-ordination of projects. Imperial does not manufacture the raw materials that make up the components and makes no warranty to said raw materials, expressed or implied. Imperial does not warrant integration hardware, adhesives,and finishing products. It is the responsibility of the client to determine the application suitability, unless said install products are supplied by Imperial.
